B. Announcements: The Board reviewed a list of upcoming meetings.

- C. Redistricting Option Approval: The Board reviewed the three redistricting option maps created for their review. Supervisor Behrens preferred 1, but 2 was acceptable; Supervisors Wasley and Humphrey preferred option 2, and Supervisor Willems preferred 3. Supervisor Anderson had previously sent in her preference for option 2, but also thought 3 was acceptable. The board will further discuss the redistricting distribution at the September Board Meeting.
- D. Encumbrance of 2013 CWF Community Partners Projects: **Resolution 14-08-03**. Supervisor Wasley moved and Supervisor Behrens.

Whereas, The MN BWSR has provided \$150,000 in FY2013 Clean Water Funds through the Community Partners Conservation Program Grant to the RCD for water quality projects installed on Faith Organizations, Schools, and Business properties;

Whereas, the BWSR cost-share shall not exceed 75% of the total construction cost; and Whereas, the RCD Board of Supervisors designates, James Landini, Washington Conservation District Staff as the technical representative for these projects.

Now therefore Be It Resolved, the RCD Board agrees to enter into BWSR cost-share agreements with the following:

Minnesota Association of Professional Employees: Spokesperson Paul Schweizer at 3460 Lexington Ave N, Shoreview, MN 55126 for bio-retention basins.

Contract #CP 13-09, Conservation Practice 712; Total Project Cost: \$127,459.12; BWSR Cost Share for eligible components: 20%/\$25,000.00. Local Watershed (Rice Creek Watershed District) Cost Share for eligible components: 20%/\$25,000.00. Landowner Contribution: 60%/\$77.459.12. Technical and Administrative amount to be consistent with percentages outlined in grant work plan.

The project must be started by November 30th, 2014 and completed by November 30th, 2015, unless otherwise amended by mutual consent and agreement by both parties.

Chelsea Heights Elementary School: Spokesperson Trinh Tranberg at 1557 Huron Street, St. Paul, MN 55108, for a bio-retention basin.

Contract #CP 13-06, Conservation Practice 712; Total Project Cost: \$24,400.00; BWSR Cost Share for eligible components: 33%/\$8,000.00. Local Watershed (Capitol Region Watershed District) Cost Share for eligible components: 67%/\$16,400.00. Landowner Contribution: 0%/\$00.00 Technical and Administrative amount to be consistent with percentages outlined in grant work plan. The project must be started by November 30th, 2014 and completed by November 30th, 2015, unless otherwise amended by mutual consent and agreement by both parties.

E. Deep Lake Project Approval: VLAWMO requested the RCD staff to complete design work to stabilize the Deep Lake Channel. **Resolution 14-08-04**. Supervisor Behrens moved and Supervisor Willems seconded. Resolved the Board approved signing the Deep Lake Channel Professional Services Agreement with VLAMO for RCD staff to complete BMP designs not to exceed \$1,330 and to be completed by December, 2015.
