Whereas, the RCD has long-standing program (1992 to the present) to reimburse LGUs and the RCD for administrating WCA, and Whereas, the RCD has agreements with the Ramsey- Washington Metro Watershed District (RWMWD), Rice Creek Watershed District ,the City of St. Paul and Vadnais Lake Area Water Management Organization (VLAWMO) to reimburse for the administration of WCA; **Whereas,** VLAWMO, RWMWD, and RCWD have all submitted documented reimbursable WCA administrative expenses for the period of June 1, 2014 through December 31, 2014; and

Whereas, the RCD has submitted documented reimbursable WCA administrative expenses for the period June 17, 2014 through December 31, 2014; and

Now Therefore Be It Resolved, the entities shall be reimbursed in the following amounts from the FY2014 WCA Administrative funds: RCWD \$1,347; VLAWMO \$2,024; RWMWD \$474.38; and RCD \$5,040.
