Subject: Proposed Updated Agenda

Dear Board Members:

Attached is a revised October expense claim from Supervisor Willems. Please replace this with the one in your board packets. Also attached is a proposed updated agenda. Initially I wanted to request moving Business Items G. Well Sealing and H. Community Partner Projects to the Consent agenda because our staff has worked to prepare those items, but they will not be attending the board meeting, so if the Board would like more time for other business items, please feel free to move these to consent agenda at the board meeting. For now, I am just proposing moving E. Budget Packet/PRAP follow-up with H. Community Partners, so that we will have more time to discuss the budget packet. The County cut our funding because the Board didn't approve this and I am still unclear what is controversial about the item. I would appreciate if anyone who has objections to items in the budget packet to please let me know, so that we could at least address the concern. I did check with the Parliamentarian to see if he had objections to moving things around in the agenda and he said, "the agenda provided in advance is not binding, only the agenda that is voted on is binding."

Also under Business Item A. Approval of Revised 2018 Budget, I did mention in the board packet that I would provide staff salary increase numbers for board consideration. I realize that with are large budget cut, that increases might be unwise to consider, but since I said I would provide the numbers and because the staff had the highest fee-for-service numbers ever, below are the numbers for salary increase consideration. I am projecting that we will finish in the black with the fund balance increasing by about \$30,000.

A standard COLA (cost of living adjustment) of 2.5% increase would be \$6,429.61 total for all the technical staff

COLA + 1% = \$8,932.65 COLA + 2% = \$11,435.69 COLA + 2.5% = \$12,687.21

COLA + 3% = \$13,938.72

Lastly, we have permission to hold our meeting in the larger Marsden room, so we should be more comfortable. If there would be any large scale emergency downtown, we would need to leave the room. Seeing that the chances of that are low, we asked to use the larger room.

Addition to Business Item H- FY18-19 Budget Packet Approval/PRAP Follow Up

WHEREAS, the Ramsey Conservation District Board of Supervisors is committed to effective water and related land resource management and service to the residents of Ramsey County; and

WHEREAS, the Ramsey County Board of Supervisors has determined that these services will be more effectively and efficiently delivered by Ramsey County; Now, Therefore, Be It

RESOLVED, the Ramsey Conservation District Board of Supervisors hereby requests the discontinuance of the Ramsey Conservation District, transfer of the duties and authorities of a soil and water conservation district to the Ramsey County Board of Commissioners and transfer of the assets, contracts and employees of the District to Ramsey County for the purpose of implementing the transferred duties and authorities; and

RESOLVED, The Ramsey Conservation District Board of Supervisors authorizes the Chair of the Ramsey Conservation District Board of Supervisors to petition Ramsey County, the Minnesota Legislature and the Minnesota Board of Water and Soil Resources to discontinue the district immediately.
