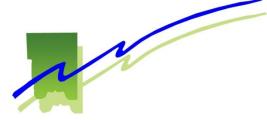

Minutes of the Board of Supervisors Regular Board Meeting held January 9, 2017.

1. Meeting called to order by Chair Humphrey at 3:04 p.m.

- A. Swearing-in of Supervisors & Group Picture: All of the Board members were elected in November, 2016 and they were all sworn in by Pamela Thompson, Ramsey County Public Works employee and notary public.
- B. Approval of Agenda: Supervisor Behrens requested taking The Comprehensive Plan Review and Budget Approval off of the agenda and review at a workshop. Supervisor Gardner agreed with the appropriateness of a workshop, but requested a brief discussion and for the agenda to remain. Motion by Supervisor Willems and Supervisor Behrens second to approve the final agenda. Motion carried unanimously.
- C. Announcements: The Board was sent a list of upcoming meetings in the board packets.
- 2. Staff / NRCS Reports: The staff updated the board on recent projects and activities. No report from NRCS.
- Approval of Standing Reports: Secretary's Report Minutes of December 12, 2016 Motion by Supervisor Willems and Supervisor Gardner second to approve the minutes. Motion carried unanimously.
- 4. Action Items
 - A. RCD Supervisor 2017 Offices and Committee Selection: **Resolution 17-01-01**. Supervisor Gardner moved and Supervisor Willems second. Resolved, the Board approved the following:

Supervisor Buggs nominated Supervisor Behrens for Chair for 2017. Supervisor Willems nominated Supervisor Humphrey for Chair for 2017. A secret ballot was taken and Supervisor Humphrey received the most votes.

Supervisor Behrens nominated Supervisor Buggs for Vice Chair for 2017. No other nominations were received.

Supervisor Behrens nominated Supervisor Gardner for Secretary for 2017. No other nominations were received.

Supervisor Behrens nominated Supervisor Willems for Treasurer for 2017. No other nominations were received.

Supervisor Behens nominated herself for Education and Information for 2017. No other nominations were received.

Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems – Voting against: none – Abstaining: none

B. Review of RCD By-Laws and Per Diem Policy: Supervisor Gardner stated that the By-Laws needed to be updated and suggested reviewing the By-Laws at the February board meeting. By consensus the Board agreed. Supervisor Gardner commented that the Per Diem Policy was not in the By-Laws, but rather was referenced in the minutes. Current board policy allows per diem for an average of four meetings per month. Ms. WhiteEagle clarified that one Supervisor exceeded the Board policy for meetings and would like a separate motion that either denies payment for the extra meetings or authorizes exception from the policy. Supervisor Buggs read aloud MN Statute 103C.315 and commented that the statute doesn't limit meetings and does not want to have limits on meeting attendance. Supervisor Humphrey requested staff to contact an opinion from the Ramsey County attorney assigned to the RCD and suggested discussion at the February board meeting, when the

budget impact could be considered. Supervisor Buggs requested policy discussion at the current board meeting, so that the Board could establish the policy and move on to other business in future meetings. Ms. WhiteEagle requested having a monthly meeting maximum established, in order to maintain the budget. Supervisor Humphrey suggested a four meeting monthly maximum. Supervisor Behrens countered with a ten meeting monthly maximum. Supervisor Gardner questioned the need for so many meetings and suggested that it would be appropriate to have them pre-approved.

Resolution 17-01-02. Supervisor Buggs moved and Supervisor Gardner seconded. Resolved the Board approved a monthly maximum of seven meetings eligible for per diem, without pre-approval needed.

Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems – Voting against: none – Abstaining: none

C. Approval of December 2016 Supervisor Expense Claims: Resolution 17-01-03. Supervisor Gardner moved and Supervisor Willems seconded. Resolved the Board approved the expense reports as submitted by Supervisors Behrens \$479.54, Gardner \$87.16, Humphrey \$125, Wasley \$134.18, and Willems \$287.80.

D. Approval of 2017 Board Meeting Dates: The Board discussed different options regarding regular board meetings. Supervisor Behrens suggested meeting evenings on the first Thursday of the month. **Resolution 17-01-04**. Supervisor Gardner moved and Supervisor Buggs seconded. Resolved the Board established 6:30pm on the first Thursday of the month for regular board meetings.

- E. Approval of 2017 MASWCD and MACD/Area IV Dues: Resolution 17-01-05. Supervisor Willems moved and Supervisor Gardner seconded. Resolved the Board approved payment of \$4,611.79 for the MASWCD dues and \$300 for MACD/Area IV dues. Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems Voting against: none Abstaining: none
- F. 2017 Professional Service Agreement Approval: Resolution 17-01-06. Supervisor Gardner moved and Supervisor Willems seconded. Resolved the Board approved the Rice Creek Watershed District professional service agreement for 2017 BMP design assistance. Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems – Voting against: none – Abstaining: none
- G. Approval of 2017 Mileage Rate/ Official newspaper: Resolution 17-01-07. Supervisor Willems moved and Supervisor Buggs seconded. Resolved the Board approved the adoption of the 2017 IRS mileage reimbursement rate of \$.535 per mile and approved the St. Paul Pioneer Press as the office newspaper for public meeting announcements.

H. Approval of Revised 2017 Budget: The operating budget was increased due to the Local Capacity grant for \$100,00. **Resolution 17-01-08**. Supervisor Gardner moved and Supervisor Willems

seconded. Resolved the Board approved the 2017 budget for \$532,950. Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems – Voting against: none – Abstaining: none

 FY16 Wetland Conservation Act Reimbursement: Resolution 17-01-09. Supervisor Gardner moved and Supervisor Behrens seconded. Resolved the Board approved the following:
 Whenese DWGD has required \$10,077 in funds for 5V16 for the number of arithmetica the DCD and LGUs.

Whereas, BWSR has provided \$16,677 in funds for FY16 for the purpose of reimbursing the RCD and LGUs for the administration of WCA in Ramsey County; and

Whereas, these funds must be spent by June 30, 2017; and

Whereas, the RCD has long-standing program (1992 to the present) to reimburse LGUs and the RCD for administrating WCA, and Whereas, the RCD has agreements with the Ramsey- Washington Metro Watershed District (RWMWD), Rice Creek Watershed District, the City of St. Paul and Vadnais Lake Area Water Management Organization (VLAWMO) to reimburse for the administration of WCA;

Whereas, VLAWMO, RWMWD, RCWD and the RCD have all submitted documented reimbursable WCA administrative expenses for the period of June 1, 2016 through December 31, 2016; and

Whereas, the City of St. Paul has submitted documented reimbursable WCA administrative expenses for the period January 1, 2016 through December 31, 2016; and

Now Therefore Be It Resolved, the entities shall be reimbursed in the following amounts from the FY2016 WCA Administrative funds: St. Paul \$1,408; RCWD \$826.50; VLAWMO \$2,300; RWMWD \$1,386.64; and RCD \$5,269.88.

J. Clean Water Fund Grant Agreement Approval: Ms. WhiteEagle informed the Board that the RCD was awarded all the Clean Water Fund grant applications that staff submitted and all the grants would be on one grant agreement, though it hadn't arrived yet. The grants were for Well Sealing (2) \$128,000, Sucker Channel Restoration \$60,500 and Community Partners \$150,000.
 Resolution 17-01-10. Supervisor Gardner moved and Supervisor Buggs seconded. Resolved the Board authorized the Chair to sign the 2017 BWSR Clean Water Fund grant agreement for \$338,500.

Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner - Voting against: none - Abstaining: none

K. Approval of Consulting Services: Resolution 17-01-11. Supervisor Willems moved and Supervisor Gardner seconded. Resolved the Board approved using the MCD ETA grant for design and engineering oversight from Stephen Mastey/Landscape Architecture, Inc. and approved the contract for up to \$20,000.

Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems – Voting against: none – Abstaining: none

L. Approval of 2017 Seasonal/Internships: Supervisor Behrens suggested contacting Professor Schultz from Hamline University, who expressed interest in the RCD offering internships.
 Resolution 17-01-12. Supervisor Behrens moved and Supervisor Willems seconded. Resolved the Board approved hiring up to two seasonal positions, not to exceed \$20,000 each and \$10,000 for an intern.

M. Comprehensive Plan Review: Supervisor Gardner expressed the desire to review the action items of the plan for outcomes. **Resolution 17-01-13**. Supervisor Behrens moved and Supervisor Buggs seconded. Resolved the Board approved February 24, 2017 from 11am-1pm as a Special Meeting/Workshop to discuss items, including the Comp Plan. Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems – Voting against: none – Abstaining: none

- N. 2017 BWSR Local Capacity Grant Agreement: Resolution 17-01-14. Supervisor Behrens moved and Supervisor Buggs seconded. Resolved the Board authorized the Chair to sign the 2017 BWSR Local Capacity Grant Agreement for \$137,500.
 Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems – Voting against: none – Abstaining: none
- O. December 2016 Procurement Purchase Approval: **Resolution 17-01-15**. Supervisor Gardner moved and Supervisor Willems seconded. Resolved the Board approved the December 2016 procurement purchases that included \$64.27 for the RCD holiday party. Voting in favor of the resolution: Behrens, Buggs, Humphrey, Gardner and Willems – Voting against: none – Abstaining: none
