- A. Approval of Agenda: **Motion by Supervisor Willems and Supervisor Wasley seconded** to approve the final agenda. Motion carried unanimously.
- B. Announcements: The Board was sent a list of upcoming meetings in the board packets. Filing to run for the 2016 RCD Board of Supervisors election opens on Tuesday, May 17, 2016 and will be open until Tuesday, May 31, 2016.

- 3. Approval of Standing Reports:
 - A. Secretary's Report Minutes of April 11, 2016

 - B. Treasury Report– Detailed 1st Quarter, 2016 Motion by Supervisor Behrens and Supervisor Willems seconded to approve the treasury report. Motion carried unanimously.

4. Action Items

A. Approval of April, 2016 Supervisor Expense Claims: **Resolution 16-05-01**. Supervisor Wasley moved and Supervisor Behrens seconded. - B. Conservation Forum Planning: the Conservation Forum is a monthly discussion on natural resource topics. Whereas, The MN BWSR has provided \$105,500 in FY2014 Clean Water Funds through the Sealing of Wells to Protect Ramsey County's Drinking Water Grant to the RCD to provide cost share for landowners to seal unused wells:

Whereas, the BWSR cost-share shall not exceed 50% of the cost to seal a well, up to \$750 per well, whichever is less and 50% of the cost to administer the grant; and

Now Therefore Be It Resolved, the RCD Board approved reimbursement for the administration and expenses of the grant from October 15, 2015 – May 6, 2016 at 50% or \$5,567.50 and reimbursement to landowners in the following amounts:

Resolved the Board approved the following: The MN BWSR had provided \$15,000 in FY 14 CWMA funding to the RCD for the cooperative control of invasive species within Ramsey County; and BWSR approved %15,000 of the grant for administration and program expenses;
