- C. Approval of 2015 Dues (RCLLG): Supervisor Willems reported on the MACD/Area IV Meeting on March 31st hosted at the RCD location.
- D. 2016-17 Ramsey County Budget Update: Ann distributed the final 2016-17 budget packet for board review. She explained that she did include a request of \$20,000 for each budget year in order to fund two additional projects, an Unsealed Well Inventory and a BMP Inventory with TMDLs. The narrative portion of the budget, which addresses the county goals, will not need to be completed until June. **Resolution 15-04-03**. Supervisor Behrens moved and Supervisor Willems seconded. Resolved the Board approved the staff submitting the 2016-17 Budget to Ramsey County.

E. Personnel Committee Update: Supervisor Wasley summarized the recent meeting of the RCD Personnel Committee, Ann WhiteEagle, and Ramsey County Attorney Harry McPeak to discuss personnel policy direction. Supervisor Humphrey explained that she is updating the Employee Handbook, which was last updated in November, 2010.

Ann explained that Ramsey County HR requested that the RCD Board decide if they would adopt the Ramsey County policy regarding background checks or develop their own policy. The county also stated that background checks for contact information that is out of the country is more expensive and takes considerably longer. **Resolution 15-04-04**. Supervisor Wasley moved and Supervisor Behrens seconded. Resolved the Board approved allowing new hires to begin work at the RCD without a background check, until a policy is adopted.
