Minutes of the **Board of Supervisors Regular Board Meeting** held December 14, 2015.

1. Meeting called to order by Chair Humphrey at 4:00 p.m.

- A. Approval of Agenda: Item F. Personnel Committee was moved to the end of the agenda and DNR Report will replace the NRCS Report. **Motion by Supervisor Willems and Supervisor Behrens seconded** to approve the revised agenda. Motion carried unanimously.
- B. Announcements: The Board was sent a list of upcoming meetings in the board packets.
- 2. DNR Report: Jenifer Sorensen, East Metro Area Hydrologist for the MN Department of Natural Resources (DNR) was present to give an update. She gave an overview of her work with RCD staff, particularly on shoreline projects, a status report on the four phases and progress of the DNR's work for the Buffer Initiative, and gave a brief report on the North & East Metro Groundwater Management Area.
- Approval of Standing Reports: Secretary's Report Minutes of November 30, 2015
 Motion by Supervisor Wasley and Supervisor Behrens seconded to approve the minutes. Motion carried unanimously.

- A. Approval of November 2015 Supervisor & Staff Expense Claims: **Resolution 15-12-01**. Supervisor Wasley moved and Supervisor Behrens seconded. Resolved, the Board approved the expense reports as submitted by Supervisors Behrens \$181.90, Gardner \$77.30, Humphrey \$88.80, Wasley \$136.50, Willems \$136.50 and staff member WhiteEagle \$56.87.

- B. FY16 BWSR Conservation Delivery & Cost Share Grant Agreement Approval: **Resolution 15-12-02**. Supervisor Behrens moved and Supervisor Willems seconded. Resolved the Board authorized the Chair to sign the FY16 BWSR Conservation Delivery & Cost Share Grant Agreement for \$29,506. The grant expiration date is December 31, 2018.

Resolved the Board approved the following: Whereas, The MN BWSR has provided \$150,000 in FY2014 Clean Water Funds through the Community Partners Conservation Program Grant to the RCD for water quality projects installed on Faith Organizations, Schools, and Business properties;

Whereas, the BWSR cost-share shall not exceed 75% of the total construction cost; and Whereas, the RCD Board of Supervisors designates, Joe Lochner, Ramsey Conservation District Staff as the technical representative for these projects.

Technical and Administrative amount to be consistent with percentages outlined in grant work plan.

Resolved the Board approved the following: The MN BWSR has provided \$150,000.00 in FY14 and FY15 Clean Water Funds through the Community Partners Conservation Program Grant to the RCD for water quality projects installed on Faith Organization, School, Business properties and the FY15 grant includes Multi-unit Residential properties;

Whereas, the BWSR cost-share shall not exceed 75% of the total construction cost; and Whereas, the RCD Board of Supervisors designated, Joe Lochner, District Staff as the technical representative for this project.

Local Watershed (Capitol Region Watershed District) Cost Share for eligible components: 33%/\$6,458.86. Landowner Contribution: 34%/\$6,608.27. Technical and Administrative amount to be consistent with percentages outlined in grant work plan.
